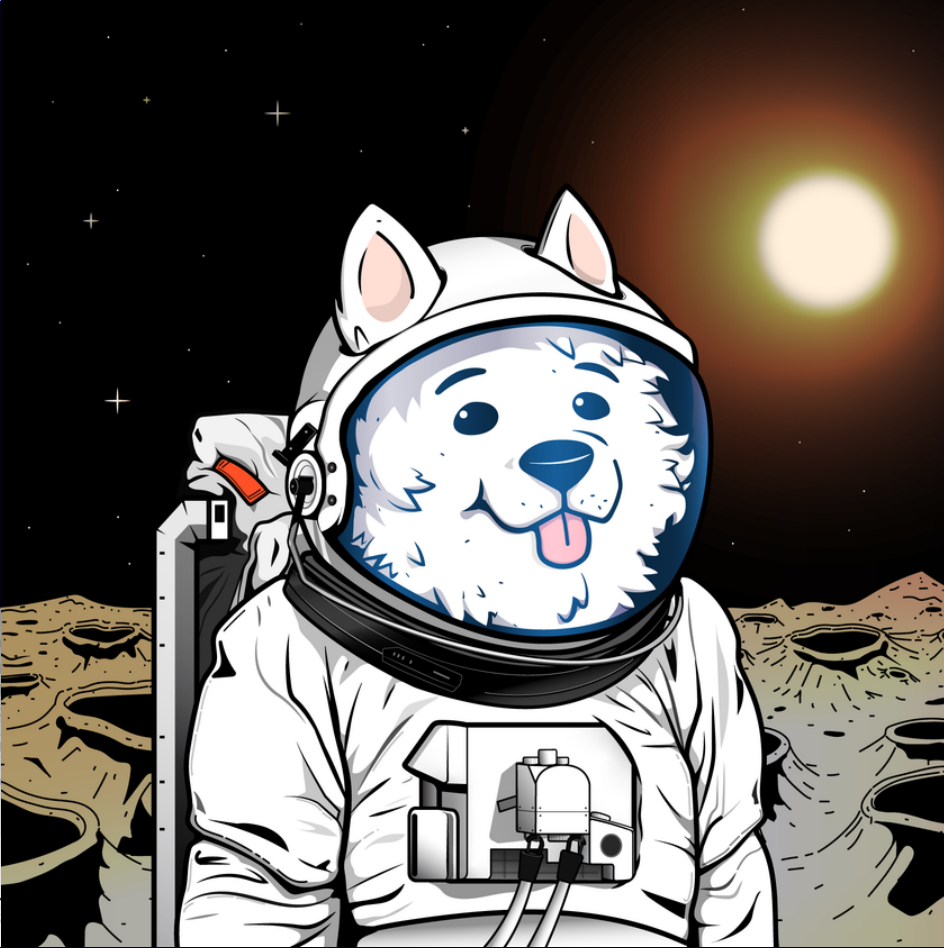
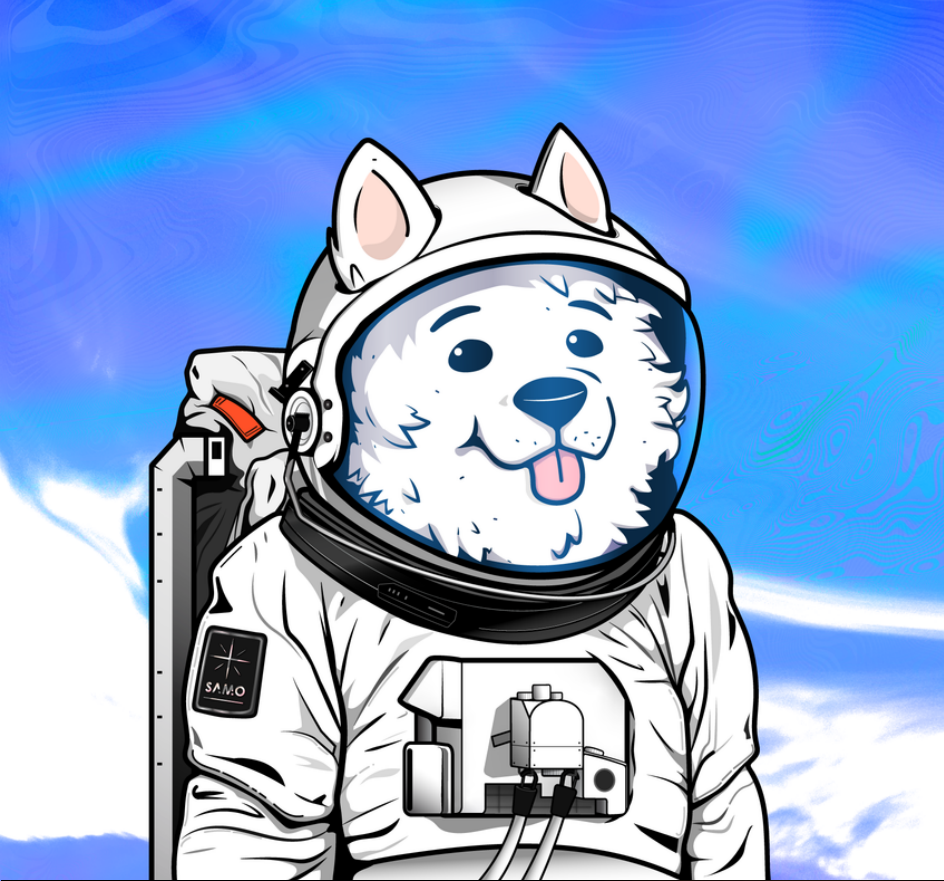

INVESTMENT PROFIT

DAO INVESTMENT AND PROFIT DISTRIBUTION FOR HOLDERS

A percentage of the initial sale will be sent to the DAO Treasury which we will invest using our strategy (which we will present more about it below) and the profit will be redistributed to every holder at specified later dates.



EXCLUSIVE ACCESS

PRIVATE EDUCATIONAL & NETWORKING PLATFORM

The holders will gain access to a **Custom Networking Platform**, which will be the main source of networking for the holders. Here the users will be able to attend monthly podcasts and webinars and to engage in conversations with crypto and business masterminds.

IT IS NOT a simple “Discord server” for networking.

It is a unique complete experience that will give access to awesome educational and networking opportunities.



THE METaverse

LANDING IN THE MOST ADVANCED METaverse

We will be settling on the Everdome Metaverse, which promises investors that is going to be the most realistic Metaverse ever.

We will have our own land in the metaverse, where we will organise donations and showcase an exhibition for community fan art.

Also, we will organise private events where only NFT holders will be able to participate

INITIAL SALE

- 10% Design and Consulting
- 5% Donation for Dog Shelter (we will prepare a list with shelters to send the donations to)
- 35% DAO Investment
- 20% Future Development (Metaverse, webinars, platforms etc.) and back-up funds in case we need them
- 30% Team



FURTHER EXPLANATION

Design and Consulting: For the design and overall project consulting team we will allocate 10% of the sales. The design is one of the main parts of the NFT collection itself, because it is going to be a PFOF collection. Unlike many other NFT projects, we respect the artists and consider that we should offer them their right compensation.

There were many complaints about artists being scamed in big NFT projects in the past, but we are not one of them and do not want to be associated with that kind of bad energy towards artists around the globe.

That is why we respect the artists. Also, the consulting for the project benefits and utility will also be rewarded from this 10% allocation, we will not use more funds for it.

The team behind the design and consulting will stick with the project to give their help along the way as much as they have the capacity to do it, but they will not be part of the team that will receive further funds. So the team percentage of sale will not include them. Team percentage will be further explained below.



DONATIONS

We will allocate 5% of the initial sale for donations. It is equivalent to around 200.000–210.000 \$. (MATIC price 1.4 USD)

We believe this is going to make a great impact on the future of the dogs that have a less fortunate fate. We love dogs, and I believe you sure do as well and we believe everyone wants to help them find a new home, so we will choose alongside you which is the best place to donate the money to, by using community vote.

We do not want to only send them money and forget about them. We will continuously promote the adoptions advertising and support the shelter in the search for a new home for our tiny friends.



DAO INVESTMENT

We will have a separate page about this, because it is one of the main parts of the collection and we want to be **as transparent as possible**.

FUTURE DEVELOPMENT:

We will allocate 20% for the future development.
What will this include?

This includes the monthly webinars and mastermind classes that we will host either in real life or on Might Networks, where the access will be gated by owning a space samoyed.

We will also invest in getting land for the Everdome metaverse, which they promise to be the most ultrarealistic metaverse in the world, built with Unreal Engine.

We will have our own land, where we will host donations for different animal helping causes and fan-art exhibitions.



TEAM

For everything we have in mind and we presented there is an extraordinary amount of work needed to complete it. Thus, we are assigning 30% of the initial sale to the team and owner of the collection.

This is going to be less than the 35% used for the DAO and less than the 35% used for the future development, donations and creation of the collection.

DAO INVESTMENT STRATEGY

We are going to use 35% of the entire sales for generating profits for the DAO, which will be redistributed to the holders. We will have three main ways in which we are going to use the 35% of the DAO treasury we have, which is approximately equal to 1.27 million \$ at the current price of Polygon MATIC. (1.4 USD)

We plan to be as transparent with our strategy of investing as possible. And we will have main decisions taken using a community vote (more info below)



How are we going to use it?

What is **our strategy?**

SEED ROUND INVESTING ON LAUNCHPADS

We are going to use the majority of the treasury -50%- to stake on Seedify and other launchpads that we are going to research on.

Why do this?

We will lock the tokens for the longest period of time possible, which is now 90 days for the highest APY possible. While generating passive income using these tokens, we will also acquire high Tiers on seedify platform, that will guarantee allocations for us and will use the funds from the treasury to get as early as possible in as many projects as we can.

We will show all the possible allocations we have and will do community votes that will decide on which does the community want to invest, alongside our preferences on what to invest.

SEED ROUND INVESTING ON LAUNCHPADS

After getting into the seed phase of IGOs and ICOs, our strategy is to sell the vested amount at the TGE (hopefully generating a small profit) and have community votes for deciding when to sell the “still vesting funds” (right after vesting, hodling until the finish of the vesting period, hodling for long term etc.).

Getting early in crypto gaming and other projects is risky and everyone should know that, but the rewards for it can be really big.



DIVIDED PORTFOLIO

We are going to use 35% of the DAO treasury to invest into a diverse crypto portfolio as follows:

- Ethereum: 25%
- Polygon: 10%
- Fantom: 15%
- Solana: 10%
- Other cryptocurrencies decided by the community: 40%

DAY TRADING BY AN EXPERT TRADER

Before reading what is the percentage of the DAO treasury we are going to use for this we need to clarify somethings for everyone investing.

Day trading is maybe one of the riskiest trading strategies existing in this world. The trader that we are going to choose to work with us nor the team **SHALL NOT BE HELD RESPONSIBLE FOR LOSING FUNDS**. This is extremely risky but posts the potential to high gains.

Although Technical Analysis was proven to work many times, it does not guarantee profit. This is why we only decided to allocate a small portion of the treasury -15%-, which adds up to only 5.2% from the entire sales (approximately 230.000\$).

We will have a really good crypto trader that will work on comissions on profits. We want to be really transparent with you about this, and that is why we will specify this to you.

We are not crypto traders and that is why we are going to work with someone else who will join the team.
